

PROCEEDINGS OF THE JOINT COMMISSIONER-1, COMMERCIAL TAXES DEPARTMENT, THIRUVANANTHAPURAM

Present: VEENA N MADHAVAN IAS

Sub:- Public Service- Commercial Taxes Department- Provisional Seniority List of Upper Division Clerks appointed to the vacancies for the period from 01.01.2011 to 31.12.2013- Finalized-orders issued-reg

Read:- Order No. G4-30956/13/CT dated 08.04.2015 and 19.06.2015 of the Joint Commissioner-1, Commercial Taxes, Thiruvananthapuram.

A Provisional Seniority List of Upper Division Clerks appointed to the vacancies in the Commercial Taxes Department for the period from 01.01.2011 to 31.12.2013 was published and circulated among the all Officers, inviting claims and objections vide order dated 19.06.2015 read above.

(2) There were 335 vacancies in the cadre of U.D Clerk during the above period. But only 330 fully eligible persons were available to be accommodated in the Seniority List against the said vacancies. Hence the remaining 5 vacancies are to be filled up from among the persons who have passed the required departmental test held in January 2011, the result of which was published by the PSC on 30.04.2011, as per Rule 28(bbb) of KS&SSRs, 1958.

(3) The claims and objections received against the Provisional Seniority List have been duly examined. The objections pointed out by the individuals comprise of claims of seniority as per Rule 13A(I)a ,13A(2) and 28(bbb) of KS&SSRs,1958, non inclusion of name, corrections regarding date of eligibility, date of birth, native place etc. Each representation has been examined in detail with reference to the relevant rules and also based on the details furnished by the respective controlling officers.

(4) Sri. Balachandran Nair. K, U.D Clerk has filed representation requesting to include his name in the Seniority List at appropriate place. The representation has been examined and found genuine. Hence it is decided to include his name as SI No.14 in between Smt. Anju. P(SI No.13) and Smt. Banchu. R Naina(SI No. 15).

(5) The following individuals have represented that they are eligible for earlier seniority under Rule 13A(1)a & 13A(2) of KS&SSRs,1958 and requested to reassign their seniority.

- i) Rakhavan. C. D
- ii) Rajendran. K
- iii) Preetha. O

(6) Their representations have been examined in detail and found that they are eligible for earlier seniority as requested and therefore they are to be placed as SI Nos 21, 100 and 111 respectively.

(7) Smt. Lakshmi.M.Nair has filed objection stating that her date of eligibility shown in column No. 6 as "30.04.11" was not correct. It is stated that she had passed all the departmental tests on January 2010 and hence requested to reassign the seniority position. On verification, it is found that she had passed all the departmental tests on January 2010 and that her probation in the cadre of L.D Clerk was

declared on 19.11.2010. Hence her request is found genuine and she is eligible to be placed in the Seniority List as Sl. No.113 in between Sri. Rajesh Kumar. B (Sl. No.112) and Sri. Vijayalakshmi. P (Sl. No.114).

(8) Smt. Sreena. K has also filed objection against her date of eligibility shown in the list. On verification it is found that her date of eligibility is shown as 24.10.11 instead of 30.04.2011. Hence necessary correction has been made in the list accordingly.

(9) The following individuals have filed objections against their position in the Provisional Seniority List with respect to that of their juniors in the lower cadre.

(10) The claim of the above individuals is to fix their seniority in the same order as that in the Seniority List of L.D Clerks or to fix the seniority based on the very same placement given to them in the order by which they were promoted to the cadre of U.D Clerk. Some of them pointed out that they were given seniority below the individuals who were promoted on later dates. Others pointed out that juniors who were promoted along with them have given earlier seniority.

(11) Sri. Shiju. S and Smt. SelinLali. A R have also filed objections stating that their names were included in the Provisional Seniority List of U.D Clerks for the period from 01.01.2009 to 31.12.2010. But their names were excluded from the final list published .They claim that their names are to be placed as Sl. Nos 1 and 2 instead of Sl. Nos 28 and 29 in the Provisional Seniority List now published

(12) The above contentions have been examined in detail with reference to the test details furnished by the concerned Deputy Commissioners. The preparation of Seniority List is not solely based on promotion orders, but strictly based on various factors which includes seniority position in the feeder category, departmental test eligibility on the date of occurrence of vacancy etc. When actual date of occurrence of vacancies are considered, a person who qualified as on that date becomes eligible for promotion irrespective of the fact that he is junior / senior. Hence the Seniority List prepared based on the above criteria is in order.

(13) Moreover the ratio fixed for L.D Clerks and U.D Typists/Confidential Assistants for promotion/ conversion as U.D Clerk is 5:1. As per this ratio, the placement of U.D Typist / Confidential Assistants in between two clerks does not repeat just same as in the promotion orders.

(14) In the light of the above, the objections filed are devoid of merits and hence rejected.

(15) The following U.D Clerks have raised the contention that Government as per G.O(Ms) No. 41/2012/P&ARD dated 23.08.2012 has reduced the period of service for category change from Typist cadre to U.D Clerk cadre from 10 years to 5 years and also recommended that the ratio of category change would be fixed in accordance with Note(3) and Rule 5(c) of KS&SSRs, 1958. They contented that no such ratio is maintained up to Sl. No. 124 in the Provisional Seniority List and hence requested for necessary ratio promotion and seniority.

(16) Contentions raised by individuals have been examined in detail. As per G.O (MS) No. 301/68/PD dated 26.09.1968 of Public (Services-D) Department, Upper Division Typists/Stenographers who have the prescribed qualifications and have put in 10 years of service will be eligible for appointment as U.D Clerks /Assistant Grade - I in every 6th vacancy arising in the concerned department. If eligible candidates are not available at the time of occurrence of vacancy, vacancies will be filled by the promotion of L.D Clerk/Assistant Grade-II.

(17) Now Government as per G.O(Ms) No. 41/2012/P&ARD dated 23.08.2012 has reduced the period of service for category change from 10 to 5 years. But the said Government order has no retrospective effect. Vacancies upto Sl. No.124 were occurred prior to the date of issuance of the above Government order, ie, from 31.03.11 to 08.07.2011. The petitioners are not eligible for the said vacancies because their date of eligibility falls after the date of occurrence of the said vacancies. The ratio between U.D Clerks and U.D Typists/Confidential Assistants is 5:1 which is strictly maintained in the list and eligible individuals were given due seniority.

(18) In the light of the above rule position, contentions raised by the individuals are baseless and hence rejected.

(19) Sri. Mahesh Kumar. S , Shaju.V A and Sri. Abhilash.T S have claimed that they are eligible for seniority, on the date following the last date of examination conducted by the PSC under Rule 28(bbb) of KS&SSRs instead of the date of publication of the result.

(20) According to Rule 28(bbb) of Pat II KS & SSRs 1958, a person will be deemed to have acquired the test qualification on the day following the last date of the whole examination or test in which he has successfully completed the examination or test by passing one or more subjects.

(21) In the Explanation (1) under Rule 28(bbb) of Part II Kerala State & Subordinate Service Rules, 1958, it is explained that the principles of the sub-rule shall apply for the drawal of increment and for promotion not involving change of duties against vacancies remaining unfilled for want of test qualified persons.

(22) As per the Explanation (1), the benefit contemplated in Rule 28 (bbb) of Part II, Kerala State and Subordinate Services Rules, 1958, will be available to a senior only if there is no test qualified person/junior on the date of occurrence of the vacancy. If there is test qualified junior on the date of occurrence of the vacancy, and if the junior is otherwise eligible for promotion as per the rules on the said date and if the result of departmental test in which the senior has appeared has not been published before the said date, then the junior is to be promoted and the benefit of test qualification will accrue to the senior only on the date of publication of the result of the departmental test.

(23) Reference may also be made to certain judicial precedents on the question involved. In Balan Vs Secretary (Taxes) 2001(2) KLT SN 25, it was observed that the fiction in Rule 28 (bbb) will apply only in cases where the promotion does not involving change of duties (ii) against vacancies remaining unfilled and (iii) where such vacancy remains unfilled for want of test qualified persons. The conditions are cumulative and if any one of them is unavailable, the fiction will not be applicable and the declaration of result of the qualifying examination will take effect only from the date on which it is actually declared. If qualified juniors are available to fill up vacancies on the date on which they arise, promotion should go to them.

(24) Further, the Government, have clarified the rule position vide Circular No. 524/R1/2014/P&ARD dated 10.03.14 that the benefit of Rule 28(bbb) of Part II, KS&SSRs 1958, will operate to promotions only on satisfying three conditions

- i. not involving change of duties
- ii. against vacancies remaining unfilled; and
- iii. for want of test qualified persons

(25) The retrospective deeming provisions that persons who passed the test/examination would be deemed to be qualified for promotion from a date prior to the date of publication of the result would operate only if all the three conditions are cumulatively present. That is if any one of these three conditions is absent, the date of publication of the result would alone govern the question whether a person has acquired the qualification of passing the test/examination for promotion or not.

(26) In the light of the above rule position, the objections raised by Sri. Mahesh Kumar. S , Sri. Shaju.V A and Sri. Abhilash.T S are devoid of merits and hence rejected.

(27) Sri. Rahul. R R has filed an objection against the Provisional Seniority List stating that he had already filed a representation requesting to revise the Seniority List of U.D Clerks with effect from 29.09.2007 and hence requested that the Seniority List may be published only after considering the said representation.

(28) The representation dated 12.08.14 filed by the individual has been examined in detail and remarks has already been furnished to Government and now the matter is pending with Government.

Hence further decision, if any, can be taken only after the receipt of Government communication. The request for kept in abeyance of Seniority List till the consideration of his request is not acceptable, as it will affect timely promotions due to the eligible hands and thereby adversely affect smooth functioning of the Department. The request of the individual for revising the Seniority List will be considered after the receipt of Government communication.

(29) Smt. Sheejarani.V.R has filed objection against the placement given to Sri. Unninarayanan. P (SI No.197) in the list. The objection raised by the individual has been examined. Although Sri. Unninarayanan. P was given conversion on a later date than Smt.Sheejarani. V.R, he is senior to Smt. Sheejarani. V.R in the Seniority List of U.D Typists. Moreover Sri. Unninarayanan. P filed willingness dated 09.08.2011. Hence the objection filed by Smt.Sheejarani.V.R is rejected.

(30) Sri. Sonu.P has filed objection stating that even though his name was placed as SI No. 202 in the Provisional Seniority List published vide Order dated 08.04.15, his seniority position was lowered to SI No. 216 in the revised Provisional Seniority List and hence requested to retain his seniority as SI No. 202.

(31) In the proceedings dated 19.06.2015, it was mentioned that the order dated 08.04.2015 and the Provisional Seniority List published were cancelled since certain mistakes were occurred. In the said proceedings it was clearly stated that even though 117 vacancies occurred on 26.04.2011, only 90 vacancies were included in the Provisional Seniority List dated 08.04.15. Hence the said list was revised, as per order dated 19.06.15, incorporating the remaining 27 vacancies. When the list was so revised, certain individuals were found eligible for seniority above the placement given to Sri. P. Sonu. Therefore his seniority position was changed in the revised Provisional Seniority List. On verification it is found that the seniority now assigned to the individual is in order and hence the objection raised regarding the placement given in an erroneous list is baseless.

(32) In the light of the above facts, the objection now raised by Sri.P.Sonu has no merits and hence rejected.

(33) Sri. S. Sunil Kumar has filed objection against his present position in the Provisional Seniority List. The individual stated that he joined as L.D Typist in Judiciary Department on 06.11.1995. Later he got inter departmental transfer to Commercial Taxes Department on 05.10.2001. Hence he claims that his service in the previous Department would be considered for conversion and seniority in the light of G.O(MS) No.301/68/PD dated 26.09.68 of Public Services(D) Department. He also contented that the system of counting service in the previous Department had been followed in many other conversion cases.

(34) The contentions of the individual have been examined in detail. As per letter No. 6124/D2/2011/TD dated 07.07.2011, Government had informed as follows:

As per the first proviso to Rule 27(a), Part-II, KS& SSRs (Added vide GO(P) No.11/76/PD dtd 13.01.1976,SRO No.149/76 dated 03.02.1976)
“Seniority of an employee getting transferred on his own request to another unit within the same department or to another department will be determined

with reference to the date of joining duty in the new Department. This proviso is an exception to the general rule (contained in clause (a) of Rule 27) that seniority of a person shall be determined by the date of order of his first appointment.”

(35) As per the terms and conditions of GO (MS) No.4/61/PD dtd 02.01.1961, an individual is entitled to seniority with effect from the date of joining duty only, vide the first proviso to Rule 27(a), Part-II ,KS &SSRs 1958. This is because a Government servant getting transferred to another unit or Department for personal considerations cannot be permitted to disturb the seniority of the employees in the department to which he is transferred. Hence, the inter departmental transfer given in the entry cadre under the terms and conditions of GO (Ms) No. 4/61/PD dated 02.01.1961 will result in loss of seniority.

(36) As Sri. S. Sunil Kumar has completed 10 years of continuous service in the cadre of Typist in Commercial Taxes Department only on 05.10.2011, he is entitled to get seniority in the cadre of Upper Division Clerk to a vacancy, which arose on or after 05.10.2011 as stipulated in GO(Ms) No.301/68/PD dated 29.09.1968 of Public (Services-D) Department. Hence he has given due seniority in the cadre of U.D Clerk. In the light of the above facts, the contention of the individual has no merits and hence rejected.

(37) Sri.Satheesh. S, U.D Clerk represented that his name was not included in the Provisional Seniority List and hence requested to include his name in between Sl. Nos. 309 and 310.

(38) On verification , it is found that his turn with respect to the seniority in the cadre of U.D Typist has not reached at all. Moreover none of his juniors in the cadre of U.D Typist have given seniority in the list overlooking him.

(39) The contention raised by the individual has been examined in detail with reference to relevant rule position and Government orders. The preparation of Seniority List is not solely based on promotion orders, but strictly based on various factors which includes seniority position in the feeder category, departmental test eligibility on the date of occurrence of vacancy etc. When actual date of occurrence of vacancies are considered, a person who qualified as on that date becomes eligible for promotion irrespective of the fact that he is junior / senior. Hence the Seniority List now prepared based on the above criteria is in order. Moreover the ratio fixed for L.D Clerks and U.D Typists/Confidential Assistants for promotion/ conversion as U.D Clerk is 5:1. As per this ratio, the placement of U.D Typist / Confidential Assistants in between two clerks does not repeat just same as in the promotion orders.

(40) In the light of the above, the objection now raised by the individual deserves no merits and hence rejected.

(41) The name of Smt.Meenarani.S was included as Sl No.150 in the Provisional Seniority List. She was promoted to the cadre of U.D Clerk as per Order dated 17.09.2012 under Rule 13A (I)a of KS&SSRs,1958. The condition was that she has to pass the required departmental tests within three years from the date of order of promotion, ie, with effect from 17.09.2012. But she has not passed the required departmental tests within the stipulated time. Hence she is not eligible for seniority in the cadre of U.D Clerk with effect from 17.09.2012. Therefore her name is to be excluded from the Seniority List.

(42) Sri. Gopalakrishnan. R was palced as SI No. 262 in the Provisional Seniority List. He was promoted to the cadre of U.D Clerk as per Order No. A3-333/2013/CT dated 09.12.2013 under Rule 13B of KS & SSRs,1958. Later, it was noticed that his probation in the cadre of L. D Clerk has not been declared so far. Hence as per Order No. A3-41561/15/CT dated 18.12.2015, he was reverted to the cadre of L.D Clerk. Therefore his name is to be excluded from the Seniority List.

(43) As a result of excluding the names of Smt. Meenarani.S and Sri.Gopalakrishnan.R from the Seniority List, two vacancies are remaining unfilled during the period of the Seniority List. Out of which, as mentioned in paragraph 4 above, one vacancy is to be filled by including the name of Sri. Balachandran Nair .K as SI No. 14. Sri. Sujeesh. K. is the senior most U.D Clerk eligible to be placed in the Seniority List against the other vacancy . His name is to be included as SI No.334 in between Sri. Dileep kumar. P.T (Sl. No.333)and Sri. Rajeshkumar. M B(Sl. No.335) to a vacancy arose on 24.11.2013.

(44) Necessary corrections in names, date of birth, native district etc. as pointed out by the concerned individuals have been incorporated.

(45) In the above circumstances, the following orders are issued.

Order No. G4-30956/13/CT dated 13.01.2016

The Seniority List of U.D Clerks appointed in the Commercial Taxes Department to the vacancies for the period from 01-01-2011 to 31-12-2013 is finalized as above. The promotions of U.D clerks enlisted in the Seniority List are regularized with effect from the date of occurrence of vacancies shown against their names.

The Final Seniority List is appended.
