In exercise of the powers conferred by section 10 of the Kerala General Sales Tax Act, 1963 (15 of 1963) the Government of Kerala, having considered it necessary in the public interest so to do, hereby, make a reduction in the rate of tax payable under sections 5 and 5A of the said Act, on the turnover of sale of Aviation Turbine Fuel filled into all domestic aircraft flights operating from Nedumbassery and Karipur International Airport to 1 percent for ten years, subject to the condition that the seller shall file a certificate issued by the purchaser as mentioned in the Annexure to this notification.
