Please see the reference cited. The sanctioned strength reported from district offices were seen not tallying with that of the actual strength maintained by the Head Office. The ratio, 1:1 between Clerks and Senior Clerks are also seen not maintained in various districts. By the letter referred 4<sup>th</sup> above, the P&ARD has given direction to the department to maintain the ratio, 1:1, between Clerk and Senior Clerk. As per the office records of Headquarters, the total sanctioned strength of Clerk and Senior Clerks is 1270. The district details show that there is a considerable difference in total cadre strength. Therefore, the discrepancies in the sanctioned strength of Clerical cadre has been reviewed and rectified with the relevant records of Head Quarters maintaining the ratio, 1:1, between Clerks and Senior Clerks and office wise sanctioned strength has been fixed as per the existing rules

complied with the direction of the Government letter cited 4<sup>th</sup> above.

Since the district Joint Commissioners are the appointing authorities of Clerks and the vacancy reporting authorities to PSC, it is mandatory to keep and maintain the actual and accurate strength, ratio etc. of Clerks /Senior Clerks under their jurisdictional control. Any laxity may lead to erroneous reporting of vacancies leading excess appointment of Clerks. Such situations will not be entertained at any cost. Therefore, utmost care should be given when vacancies are reported either to Headquarters or to PSC. The following instructions are to be strictly adhered to in this regard.

The respective Joint Commissioners are instructed to maintain the strength of Clerks and Senior Clerk posts as allotted in the proceedings referred 5<sup>th</sup> above. It was found that certain Joint Commissioners are not maintaining the actual sanctioned strength of Clerks in various offices. This has been corrected and the actual strength has been fixed vide proceedings referred 5<sup>th</sup> above. Any vacancies of Clerks that would arise consequent to the revision of sanctioned strength and maintaining the 1:1 ratio shall be reported to PSC only on getting concurrence from the Headquarters. This office will verify the vacancy reported by respective Joint Commissioners in order to find that the 1:1 ratio is accurately maintained. Such vacancies may only be reported to PSC after promotion orders of Clerks to Senior Clerks are issued and after getting instructions in this regard from this office.

In the wake of impending restructuring of the State GST Department, Kerala, it is imperative to maintain correct and actual account of sanctioned strength, ratio preferences etc. of different cadres. To begin with, as per the read 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> papers above, steps were taken to migrate the cadre details and data of all the employees to SPARK platform as validated by the drawing and disbursing officers and by the cadre controlling authorities of respective districts. Once the data are updated and confirmed, it forms the basis of the cadre

management and employee service events, procedures, programmes etc. On taking into account of the existing parameters related to sanctioned strength, ratio preferences etc., the updated data need to be validated. The department, after careful consideration of the updated data and keeping in view the importance of data updating process, noticed certain discrepancies with regard to the maintenance of 1:1 ratio between Clerks and Senior Clerks against their office wise sanctioned strength in districts.

This strength is maintained at the ratio of 1:1, with 635 posts of Clerks and 635 posts of Senior Clerks. On verification of cadre wise sanctioned strength received from sub-offices, it has been noticed that the sanctioned strength reported with respect to the cadres of Clerk and Senior Clerk are not tallying with the actual sanctioned strength of the department. The 1:1 ratio between Clerks and Senior Clerks is also seen not maintained in districts. By the letter read 4<sup>th</sup> above, the P&ARD has instructed to maintain the 1:1 ratio between Clerk and Senior Clerk in each district. In order to avoid the distortion in cadres and to ensure the ratio between Clerk and Senior Clerk and Senior Clerk, the strength of the Clerical cadres in each office of a district has to be reviewed with the strength of relevant records in the Head Quarters.

The back tracking of the records in the Head Quarters reveals that at various occasions, the clerical posts were created, shifted or upgraded consequent to the establishment of new offices / wings or sometimes with the abolition / merging of offices or as per the requirements and specific strength of officials were also allotted to each office. The sanctioned strength of various cadres within an office of the department was fixed as per G.O. (Ms) No.134/84/TD dated 21.08.1984. Since the administration of the department for the period upto 1998 -99 was vested with the Board of Revenue (Taxes) and thereafter, renamed as Commercial Taxes Department, Kerala and subsequently as State Goods and Services Tax Department, Kerala, the records of the Board of Revenue (Taxes), the Commercial Taxes Department and the State Goods and Services Tax Department, Kerala were taken into account for ascertaining the cadre details pertaining to Clerical posts.

The sanctioned strength of Clerks and Senior Clerks during the year 1994-95 was found as 1252. In the year 1995-96, 1997–98, 1998 -99 and 2008-09, certain number of Clerical posts were created viz. 87, 19, 6 and 6 respectively as per orders read 6<sup>th</sup> to 11<sup>th</sup> above and the sanctioned strength was raised to 1370. In the year 2010, Hundred posts of Upper Division Clerks were upgraded to the post of Commercial Tax Inspectors. Consequent to the upgradation of Upper Division Clerks, the strength of Clerical cadre became reduced to 1270. This strength has been fixed to the ratio of 1:1 between Clerks and Senior Clerks as 635: 635 vide the departmental proceedings no.A1.38772/2009/CT dated 27.05.2010. The figure 635: 635 lies as such as the sanctioned strength between Clerks and Senior Clerks thereafter.

No posts of Clerks or Senior Clerks were abolished till date. The details are summarized as below.

The cadre review also shows that there were many sequential events of shifting of

clerical posts consequent to the formation / abolition of offices/ wings in tune with the introduction of Acts like VAT, GST etc. and as per the organizational revamping of the Department. All those events were worked out and mapped together to arrive at the actual account of sanctioned strength of Clerical cadre that had existed or have been continued in each office in a district. The scrutiny shows that the following offices were keeping incorrect figures of sanctioned strength against the actual strength of Clerical posts as detailed below.

The respective Joint Commissioners are hereby directed to maintain the strength of Clerks and Senior Clerk posts as shown above. Since the rule related to DRB is to be strictly adhered to, if any number of Clerks that would be found in excess of the sanctioned strength of Clerks in a district will be permitted to retain in the same district and will be temporarily accommodated them in the sanctioned strength of Senior Clerk. When any Clerk in the district will be promoted to the cadre of Senior Clerk, they will be absorbed into the sanctioned strength of Senior Clerk allotted to that district till the ratio of sanctioned strength becomes 1:1.

The authorities entitled to maintain the cadre strength of Clerks in each district shall record the sanctioned strength of Clerks and Senior Clerks as allocated in the above table and the posting of officials will be strictly in accordance with the sanctioned strength maintaining the ratio as stipulated in relevant rules. As specific sanctioned strength has been fixed in each and every office, utmost care should be given when any promotion / by transfer appointment will be made to the sanctioned strength of Clerk and Senior Clerk. Strict observance should also be warranted when the vacancies in the clerical cadre will be reported to PSC.

The respective Joint Commissioners and controlling authorities shall maintain the register of posts related to various cadres and update the same periodically without fail. Necessary updations have to be effected in SPARK, Treasury offices, Establishment Registers and other records. The transfer / promotion of the employees of an establishment should be recorded strictly in the Establishment Register.

A certificate mentioning the currently re-fixed strength of Clerks and Senior Clerk posts and the updations made in this regard under the jurisdiction of each Joint Commissioner should be forwarded to the undersigned within two days.

This order will take immediate effect.
