ORDER

As per Government Order read as 1st paper above, the State Goods and Services tax Department has been re-organized with constitution of various new formations. In order to implement the restructuring ordered vide Government Order read above, the Commissioner of State tax has been authorized to deploy sufficient Clerks/ Senior Tax Assistants / Typists / Computer Assistants and other supporting staff among various offices based on work load and to divide final location, building etc for the setting up of Offices, the functions of distribution of vehicles and other infrastructure requirements.

The Commissioner of State tax as per letter read as 2nd paper above has furnished a comprehensive proposal for establishing

functional offices with required staff strength.

Government hereby approves the proposal furnished by the Commissioner of State Goods and Taxes Department, vide letter read above, which is appended. Vide the restructuring Government Order, the salaries and establishment matter of all the employees in a revenue district are ordered to be dealt in respective Joint Commissioner Taxpayer Services. Therefore, the lien in respect of all the employees of various verticals in a revenue district will be attached to the office of the Joint Commissioner Taxpayer Services. Even though the lien is admitted in Joint Commissioner Taxpayer Services, the employees will be deployed to various other offices of corresponding verticals for utilizing their service in accordance with the strength accommodated as shown in Table-1. The salaries, allowances and other emoluments such as HRA, CCA etc. of such employees deployed in other offices of a revenue district will be applicable as per the prevailing norms depending on the jurisdiction of Corporation, Municipality (District Head and Others) or Panchayat area under which the place of office of that employee situated and as per any other prevailing norms applicable. No other claim will be available to the employees in this regard except that may apply with the change in norms from time to time. Therefore, it is the responsibility of the Joint Commissioner Taxpayer Services to make correct entries in the SPARK platform regarding salaries, allowances and other emoluments such as HRA, CCA etc. allowable to an employee applicable to the place of office inwhich the employee is accommodated as per the above Table-1. Necessary provision for making such an option for salaries, allowances and other emoluments such as HRA, CCA etc. applicable to an employee based on their place of office shall be provided by the SPARK.

In the case of transfer and postings of officials, the cadres of and above the cadre of Deputy Commissioner will be issued by the Government on proposal by the Commissioner and that of and below the cadre of Assistant Commissioner will be issued by the Commissioner. For the transfer and postings of officials of and below the cadre of Deputy State Tax Officer, the Special Commissioner will issue the orders by posting or allotting the officials to respective verticals. Consequential posting

orders shall be issued by the respective Joint Commissioners of zonal/district heads of corresponding verticals and shall be intimated to respective district Joint Commissioner Taxpayer Services to make necessary entries in Service Books and SPARK.

As per the restructuring Government Order, the Head Clerks who are not qualified to the post of Assistant State Tax Officer have been ordered to maintain in the department on ad hoc basis. Therefore, the strength of such Head Clerks who are not qualified to the post of Assistant State Tax Officer will be retained in the department on ad hoc basis and whose lien is admitted in the office of the respective Joint Commissioner Taxpayer Services from their existing offices. The vacancies accrued on promotion / retirement, these Ad hoc Head Clerk posts will be abolished from these offices.

Vide the restructuring Government Order, abolition of 140 Office Attendant posts and 200 Typists posts have been ordered. The existing sanctioned strength of Office Attendant post is 568. On abolition of 140 Office Attendant posts, the strength will be 428. This strength has been deployed in column no. (10) in the above Table-1. The excess strength of 140 Office Attendant posts are maintained in respective Districts in the office of the Joint Commissioner Taxpayer Services adhering to keep DRB Rules. These excess Office Attendant posts will be abolished as and when vacancies will arise in the Office Attendant cadre. Therefore, the vacancies of Office Attendant posts that may arise on promotion/conversion/retirement etc. shall not be reported to PSC until the cadre strength reaches to 428. At the same time, certain excess Office Attendant posts attached to the districts will be shifted and attached to other districts in the office of the Joint Commissioner Offices Taxpayer Services on occurrence of vacancies for meeting the demand. As it is necessary to shift and attach the Office Attendant posts from a district to another, the Commissioner is authorized to shift and attach the Office Attendant posts by calling for option from employees. The shifting and abolition of excess posts of Office Attendant posts is shown as below in Table-2.

The deployment of Typist in the column no.(7) in the above Table-1 is made with the current strength of 407 Typist. Therefore, the vacancies of Typist posts that may arise on promotion/conversion/retirement etc. shall not be reported to PSC until the strength reaches to 207. For the abolition of 200 posts of Typists, the vacancies accrued shall be adjusted towards the abolition of 132 Typists posts from DC Audit offices (ie. 2 posts from each DC Audit), 31 posts from DC Taxpayer Services Division (ie.1 post from each DC Division), 15 posts from DC Intelligence (ie.1 post from each DC Intelligence), 15 posts from Taxpayer Services JC Offices (ie.1 post from each District JC Office) and 7 posts from JC Audit Offices (ie.1 post from each JC Audit Offices) mentioned in column no.(7) in the above Table-1. Consequential orders for abolition of posts shall be issued by the Commissioner on abolition of various kinds of posts.

Vide the restructuring Government Order, the salaries and establishment matter of all the employees in a revenue district are ordered to be dealt with in respective Joint Commissioner Taxpayer Services. Therefore, the lien in respect of all the employees of various verticals in a revenue district will be attached to the office of the Joint Commissioner Taxpayer Services. Even though the lien is admitted in Joint Commissioner Taxpayer Services, the employees will be deployed to various other offices of corresponding verticals for utilizing their service in accordance with the strength accommodated as shown in Table-1. The salaries, allowances and all other emoluments such as HRA, CCA etc. of such employees deployed in other offices of a revenue district will be as per the prevailing norms applicable to the jurisdiction of Corporation, Municipality (District Head and Others) or Panchayat area under which the place of office of that employee situated and as per any other prevailing norms applicable. No other claim will be available to the employees in this regard except that may apply with the change in norms from time to time. Therefore, it is the responsibility of the Joint Commissioner Taxpayer Services to make correct entries in the SPARK platform regarding salaries, allowances and other emoluments such as HRA, CCA etc. allowable to an employee applicable to the place of office in which the employee is accommodated as per the above Table-1. Necessary provision for selecting such an option for salaries, allowances and other emoluments such as HRA, CCA etc. applicable to an employee depending on their place of office shall be provided by the SPARK.

In the case of transfer and postings of officials mentioned in Table-1, the Special Commissioner will issue the orders by posting or allotting them to respective verticals. Consequential posting orders shall be issued by the respective Joint Commissioners of zonal/district heads of corresponding verticals and shall be intimated to respective district Joint Commissioner Taxpayer Services to make necessary entries in Service Books and SPARK. Seniority and all other related matters of employees will be applicable as per norms. When the lien of a cadre in a district is shifted to other district, the juniormost official holding in the cadre of that district will be transferred as per norms. The Joint Commissioner Taxpayer Services of a revenue district will be the vacancy reporting authority to PSC. In Ernakulam revenue district, the Joint Commissioner Taxpayer Services, Ernakulam will be the vacancy reporting authority to PSC.
