Subsequently, as per reference 6th ,7th and 8th cited, Smt.Nazreen Jamal P J,Senior Clerk (O/o the STO,First Circle, Kalamasseri), Smt.Meera P M, Senior Clerk (O/o the STO ,Third Circle, Ernakulam), and Shri.Pratheesh P S, Senior Clerk (O/o the STO, Second Circle, Kalamassery) filed representations stating that as per Order No.CT/15489/2017-G2 dated 04/08/2022 of the Special Commissioner, they are included in the revised Final Seniority list of Clerks appointed to the period from 01.01.2014 to 31.12.2016 and their seniority has been reassigned as Sn No.170, Sn No.172 and Sn No.174 respectively.
