1. INTRODUCTION

The State Goods and Services Tax (GST) Department has launched a prestige IT project named "Lucky Bill " mobile App. The Lucky Bill mobile App is a unique IT initiative of government of Kerala. The lucky bill mobile app helps the department to gather the sales information directly from the end customers as an alternative source of trade data. The scheme is designed to encourage the consumers to demand bills on making purchase and force traders to issue accurate bills, also this will indirectly compel the traders to declare the accurate and correct sales information in their GST return.

In a bid to make the scheme more attractive, government is offering various prizes including cash prizes to the public who upload GST invoices after making purchase. Prizes worth five crore are offered annually under this scheme. Bills uploaded via the app stand to win prizes through daily, weekly and monthly draws in addition to a bumper prize of 25 lakh. The prizes of the daily draws consist of kudumbasree gift packet worth 1000 each for 25 winners and of vanasree gift packet (Forest products) worth 1000 each for 25 winners. The weekly prize is a three-day/two—night family accommodation package offered by the Kerala tourism development corporation for 25 winners in their prestige properties.

2. GENERAL CONDITIONS

- The ideas of the float should be portrayed in such a way that it attracts public attention.
- Use of hazardous materials and explosives in float should be avoided.
- The float measurement should not exceed; Length- 18 feet, Height 16 feet from the road, width-10 feet.
- The construction of the float should be done in accordance with the green protocol.
