NOTIFICATION

- G. O. (P) No. 198/2013/TD. Dated, Thiruvananthapuram, 16th November, 2013.
- S. R. O. No. 905/2013.—In exercise of the powers conferred by subsections (3) and (5) of section 11 of the Kerala Finance Act, 2013 (29 of 2013), the Government of Kerala hereby make the following rules, namely:—

RULES

- 1. Short title and commencement.—(1) These rules may be called the Mangalya Nidhi Cess Rules, 2013.
 - (2) They shall come into force on 23-7-2013.
 - 2. Definitions.—In these Rules, unless the context otherwise requires,—
 - (a) "Act" means the Kerala Finance Act, 2013 (29 of 2013);

- (b) "Form" means a form appended to these Rules;
- (c) "Proprietor" means the proprietor of a hotel or auditorium entrusted with the collection of Mangalya Nidhi Cess under sub-section (2) of section 11 of the Act.
 - (d) "Section" means a section of the Act.
- 3. Registration of establishments.—The proprietor shall apply to the assessing authority under the Kerala Tax on Luxuries Act, 1976 (32 of 1976) having jurisdiction over the area where the hotel or auditorium which is entrusted with the collection of Mangalya Nidhi Cess, is situated, in Form No. I for obtaining a unique identification number. The procedure relating to the Registration of a hall/auditorium/kalyanamandapam or place of similar nature in the Kerala Tax on Luxuries Act, 1976 shall be followed by the assessing authority for the registration of such hotel or auditorium:

Provided that in the case of hotel or auditorium which are already registered under the Kerala Tax on Luxuries Act, 1976, filing of Form No. I is sufficient for this purpose.

- 4. Filing of statements.—The proprietor shall file a statement referred to in sub-section (3) of section 11 in Form No. II, on or before the 15th day of every month, before the assessing authority.
- 5. Maintenance of Register.—The proprietor shall keep a register containing the details of remittance of Mangalya Nidhi Cess referred to in sub-section (3) of section 11 of the Act in Form No. III.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

Sub-sections (3) and (5) of section 11 of the Kerala Finance Act, 2013 (29 of 2013) empowers the Government to prescribe the form for filing the statement to the assessing authority, the manner of keeping a register containing the details of remittance of *Mangalya Nidhi Cess* and the manner of submitting application for a unique identification number. Accordingly, the Government have decided to make rules for this purpose.

The notification is intended to achieve the above object.
