Consequent on the introduction of "Goods and Services Tax" system in the State of Kerala, the Government vide order read as first paper above were pleased to re-name the Commercial Taxes Department as "State Goods and Services Tax Department, Kerala". Subsequently, the Government vide GO read as second paper above have changed the designation of the officers in accordance with the Kerala Goods and Services Tax ordinance, 2017. This situation warrants redesignation of the State Public Information Officers and Assistant State Public Information Officers of the State Goods and Services Tax Department, Kerala. (4) The Deputy Commissioner (Law), Ernakulam and Deputy Commissioner (Appeals), Kollam, Kottayam, Ernakulam and Kozhikode shall issue orders designating State Public Information Officers, Assistant State Public Information Officers and first Appellate Authorities of their respective offices and report compliance.
