Consequent on the introduction of 'Goods and Services Tax' system in the State of Kerala, the Commercial Tax Department is re-named as 'State Goods and Services Tax Department, Kerala' vide order read as 1st above. Subsequently, the Government vide GO read as second paper above have changed the designation of the officers in accordance with the Kerala Goods and Services Tax Ordinance 2017. This situation warrants re-designation of the State Public Information Officers and Assistant State Public Information Officers of the SGST Department, Kerala. Accordingly, the Hon'ble Commissioner designated the posts in the District level offices as State Public Information Officers and First Appellate Authority vide order read as 3rd above. It is also directed to issue orders designating the Assistant State Public Information Officers in the district offices and State Public Information Officers and Assistant State Public Information Officer and first Appellate Authority in the offices coming under the jurisdiction of the district level offices.

Direction has also given to exhibit the details of the designated officers in front of the office premises and to ensure the compliance of the above directions by submitting a certificate of compliance within a period of one month from the date of order of the Hon'ble Commissioner.
