As per Pay Revision Order No. 7/2016/Fin dated: 20.01.2016, Government have sanctioned higher grade for 1/3rd of the Sanctioned strength in the cadre of Junior Superintendent and Inter-Changeable Posts as per Special Rules in all departments w.e.f. 01.04.2016. In State GST Department Erstwhile Commercial Taxes Department, the post of Junior Superintendent is interchangeable to Assistant State Tax Officer. The present sanctioned strength of such posts in this department is assigned as 985.
