### **Explanatory Note**

The DPC (Lower) held on 16-7-2019 selected Sri Biju, P. P. (Sn. No. 108/10) for promotion to the cadre of State Tax Officer. His name was included in the Select List for the year 2019 as Sl. No. 41. He has not been promoted to the cadre of State Tax Officer as he was suspended from service as per order No. DC(I) K2/1771/19, dated 20-7-2019 of the Deputy Commissioner (Int.), Kozhikode. Meanwhile, a disciplinary case was initiated against the individual in File No. A12-9627/19/TX. MOC issued on 1-11-2019. Sri Biju, P. P. was reinstated into service vide order No. CT/9627/2019-A12 dated 1-2-2020. The disciplinary action case is pending. Therefore, the Departmental Promotion Committee (Lower) held on 14-2-2020 decided to remove his name from the Select List of 2019. Hence the amendment.
