Sub:- Seniority List of Commercial Tax Officers for the period from 01.01.2008 to 31.12.2010- Finalised-Orders issued-reg

Read:- Order No. G1 32105/2013/CT Dt.21.03.2014

A provisional Seniority List of Commercial Tax Officers appointed for the period from 01.01.2008 to 31.12.2010 was published and circulated among the staff of the department; vide order read above inviting objections, if any, from the affected persons.

Altogether 11 objections were received against the list from different categories like promotees, direct recruits and all the objections were examined in detail. The merits of arguments have been evaluated in the light of the relevant Rules of KS&SSR and Special Rules, Court directions and with reference to the connected facts and circumstances of the case.

Among those, the objections filed by the following directly recruited CTOs were common in nature.

1. Sri.Sujesh.P
2. Sri.Jayasankar.P
3. Sri. Dinesh Kumar.M
4. Sri. Hari Kumar.S
5. Sri. M.C. Agasthikutty

Objections raised by them are as follows:

1. That there were 553 posts of CTOs existed in the Department from the year 2005 and 27 posts even if classified as temporary are to be treated as substantive vacancies as per Special Rules of this Department. They have relied upon the Judgment in OP 12278/96 dt. 10.08.2004, in which the Hon'ble Court has ordered continuous seniority for the candidates appointed from the same Rank List, as the authorities did not report them to the PSC as a lot for making advice, even if they were available when the Rank list was published.
2. There were only 99 directly recruited CTOs available in the Department as on 22.08.2007 and the balance 6 posts earmarked for direct recruits were not even reported to PSC.
3. In addition, Sri.Harikumar.S and Sri. M.C.Agasthikutty raised the contention that even though they were advised by the PSC vide RIC(2) 34660/07/GW dt.26.03.2008, they may be assigned seniority just below the 48 candidates who

were advised by the PSC as per RIC(2) 34660/07/GW dt. 22.08.07, as they were advised against the NJD Vacancies reported in RIC(2) 34660/07/GW dt. 22.08.07

The objections have been examined in detail. The Government refixed the permanent cadre strength of CTOs/STOs in the Commercial Taxes Department as 553 and a quota of 20% for Direct Recruitment, i.e, 111 posts, vide GO(MS) No. 49/08/TD Dt.08.03.2008. The said Government Order has no retrospective effect. Quota is always fixed against the substantive vacancies. The cadre strength as per GO(MS) No.49/08/TD Dt.08.03.2008 was taken into account while calculating quota.

The contention that there were only 99 Directly Recruited CTOs available in the Department as on 22.08.2007 was examined in consultation with A8/TX Section and with reference to File No.A8 37286/07/TX and found that the number of directly recruited CTOs, as on 22.08.2007 were 102, against the cadre strength of 105. The details of Directly Recruited CTOs available were as follows:

The balance 3 vacancies available included 2 NJD vacancies in RIC(2) 34660/07/GW Dt.22.08.2007. Sri.S.Harikumar and Sri.M.C.Agasthikutty were advised by the PSC as per RIC(2) 34660/07/GW dt.26.03.2008, against the above NJD vacancies which were reported to PSC on 07.12.2007 .

There is no lapse on the part of the Department in reporting vacancies to the PSC on time. The 2 NJD vacancies occurred against the advice dt.22.08.2007, were reported to PSC on 07.12.2007, and the vacancies which arose due to the refixation of Cadre Strength based on GO(MS) No. 49/08/TD Dt.08.03.2008, has been reported on 28.03.2008. In the above scenario it can be seen that the judgment in OP 12278/96 dt. 10.08.2004, is not applicable in the instant case.

The direct recruitment of CTOs is made in accordance with the SRO 1763/90. As per the said SRO, those candidates are entitled for seniority from the first effective date of their advice. Though the direct recruits can claim seniority in the post only from the first effective date of PSC advice, the departmental hands who were promoted to the vacancies earmarked for direct recruits, are not entitled to raise any preferential claim over direct recruits with respect to matters such as seniority and promotion, by virtue of such temporary appointment/promotion. Such temporary appointees /promotees can claim seniority in the post only from the date of occurrence of vacancy in the post to which they are entitled as per the quota prescribed in the Special Rules, subsequent to the regularization of their temporary appointment from such a date. However, if there are persons who were promoted based on the Select List prepared as per the provisions of

Rule 28(b)(i) of Part II KS&SSRs and they were against the vacancies to which they are entitled as per the quota prescribed in the Special Rules, orders as regular.

To make it clear, if a departmental hand is promoted to a vacancy earmarked for direct recruitment and if the vacancy to which the department hand is eligible as per the quota prescribed for promotion arises after the date of first effective advice of the direct recruit and the departmental hand is entitled to get seniority in the post from the date of occurrence of vacancy to which he is entitled as per the quota prescribed in the Special Rules.

Hence cadre strength ~~was~~ fixed on their respective date of advice and excess promotees provisionally promoted in the quota earmarked for direct recruits were pushed down to accommodate the directly recruited CTOs. As such, the final seniority List of CTOs for the period from 01.01.2005 to 31.12.2007 was revised as per Order No. G1 34281/12/CT dt.07.09.2013, in compliance with the Govt. Order No. GO(Rt)648/2013/TD dt.24.08.2013 pushing down the excess promotees thus provisionally promoted.

Thus the cadre strength of directly recruited CTOs as on 26.03.2008 can be calculated as under:

Hence the contention that all the 122 promotions made as per Order No.A8 200/07/TX Dt.01.08.2007 & Order No.A8 300/08/Tx Dt.02.02.2008 prior to the date of advice of Sri.Harikumar.S and Sri.M.C.Agasthikutty is provisional and they were accommodated against the vacancies earmarked for the Direct Recruits, is against the facts, as only 9 vacancies were available for direct recruits against their quota as on 26.03.2008. It can be otherwise read as, all the other 113 promotee officers who were promoted based on the select List prepared as per the provisions of Rule 28(b)(i) of Part II KS&SSRs and who were accommodated against the vacancies to which they are entitled as per the quota prescribed in the Special Rules, can be treated as regular. Hence 9 promotees are to be pushed down to accommodate the directly Recruited CTOs. In the Provisional Seniority List, only three persons were so pushed down. As the Cadre Strength is refixed as 111, w.e.f 08.03.2008, six more persons are to be pushed to accommodate the direct recruits. As such, the following six promotee officers, are to be placed just below Sri.M.C.Agasthikutty.

- 1) Rajagopal.M
- 2) George.G
- 3) Baiju.S
- 4) Krishnan Nair. A
- 5) Geetha.M
- 6) Ram Kumar.S

Hence the objections filed by the following officers are devoid of merits and liable to be rejected.

- 1) Sri.Sujesh.P
- 2) Sri.Jayasankar.P
- 3) Sri. Dinesh Kumar.M
- 4) Sri. Hari Kumar.S
- 5) Sri. M.C. Agasthikutty

The objections filed by other officers are discussed below.

Sri.Dominic Rajan and Sri.D.Prasad have filed objections against their placement in the Seniority List on the ground that, three officers who have been promoted to the cadre of CTOs in subsequent orders were assigned higher rank in the Provisional Seniority List.

The objections have been examined in detail. Sri.Jayan.M.D, who was promoted to the cadre of Commercial Tax Officer as per Order No. A8.3000/09/TX dt.12.08.2009 has been assigned Sl.No.10 in the List. This is because, the name of Sri.Jayan.M.D has been included with retrospective effect in the Final Seniority List of ACTOs for the period from 01.01.2000 to 31.05.2002 as Sl.No.78(a) in between Sri.Jose P.P and Sri.M.Raghavan as per Order No. G1 16763/06/CT Dt.06.03.2009. Accordingly the DPC(Lower) held on 25.06.2009 decided to select and include his name in the Select List for 2008 as Sl.No. 9(a) just below Sri.Jose.P.P.

In obedience to the order dt.01.06.2010 of the Hon'ble High Court of Kerala, the DPC(Lower) held on 11.06.2010, decided to select and include the name of Sri.K.Raveendran in the Select List for 2008 as Sl.No.18(a) in between Sri.T.Padmajakshan and Sri.A.V.Prabhakaran restoring his original seniority. Accordingly, Sri.Raveendran.K, who was promoted to the cadre of Commercial Tax Officer as per Order No. A8.1000/10/CT Dt.12.07.2010, has been placed in between Sri.Padmajakshan.T and Sri.Prabhakaran.A.V, restoring his original seniority.

Sri.Thaha P.E, who was promoted to the cadre of Commercial Tax Officer, vide order No. A8 3000//09/TX Dt.07.02.2009 has assigned Sn.No. 34 in the Provisional Seniority List. The DPC (Lower) held on 24.12.2008 decided to select and include Sri.Thaha .P.E as Sl.No. 9 in the Select List for 2008. Later the DPC(Lower) held on 15.03.2011, decided to revise the Select List for 2008, by including the name of Sri.Thaha.P.E as Sl.No.33(a) in between Sri.Dominic Rajan and Sri.K.Sivadasan, restoring his original seniority. So the placement given to the officers are in order and hence the objections filed by Sri.Dominic Rajan and Sri.D.Prasad are rejected.

Sri.Shain.V.D has filed objection against the Provisional Seniority List, stating that his date of birth is noted as '27.05.1967' instead of the correct date '27.05.1962'. The objection filed is examined and necessary corrections have been made in the Final Seniority List as requested.

Similarly, Sri.G.Ajayakumar has filed objection against the Provisional Seniority List, stating that his date of birth is erroneously mentioned as '06.01.1964' instead of correct date '06.11.1964'. His request was examined with reference to the attested copy of relevant page of his SSLC Book and necessary corrections have been made in the Final Seniority List as requested.

Sri.P.A.Johnkutty and Sri.V.Saji Jacob have filed objections, stating that they are eligible to be included in the Select List for 2007 and 2008, and requested to restore their seniority.

At present, the positions assigned to Sri.P.A.Johnkutty and Sr.V.Saji Jacob are based on the decisions taken by the DPC(Lower) held on 24.12.2008 and 23.03.2010 respectively and based on the Select list for the year 2008 and 2010 and hence the objections filed in this regard deserves no merit for consideration.

The DPC(Lower) held on 03.06.2014 considered the review petitions filed by Sri.C.Vinodchand, Sri.S.Karmachandran Namboodiri, Sri.Y.Salahudeen and Sri.Joy Joseph for restoration of their seniority.

The Committee decided to include the name of Sri.C.Vinodchand as Sl.No.11(a) in between Sri.M.Sivasankaran Nair(Sl.No.11) and Sri.C.D.Babu(Sl.No.12), Sri.Karmachandran Namboodiri as Sl.No.62(a) in between Sri.P.Chandramohanan Nair (Sl.No.62) and Smt.Ambika.V(S.No.63) and Sri.Y.Salahudeen as Sl.No.77(a) in between Smt.M.Geetha (Sl.No.77) and Sri.S.Ramkumar(Sl.No.78) in the Select List of Asst.Commercial Tax Officers eligible for promotion to the cadre of Commercial Tax Officers for the year 2008 and to include Sri.Joy Joseph, as Sl.No.9(a) in between Sri.G.Gopinathan (Sl.No.9) and Sri.V.M.Abdul Kareem(Sl.No.10) in the Select List of Assistant commercial Tax Officers eligible for promotion to the cadre of Commercial Tax officers for the year 2009. Hence the name of Sri.C.Vinodchand, Sri.S.Karmachandran Namboodiri, Sri.Y.Salahudeen and Sri.Joy Joseph have been included in the appropriate positions.

In the circumstances the following orders are issued.
