The Departmental Promotion Committee (Lower) was convened on 13.02.2023 for preparing the Select List of Assistant State Tax Officers for the year 2023 for promotion to the cadre of State Tax Officer. Government, as per letter read as 1<sup>st</sup> above, have approved the Select List. 47 Nos of Assistant State Tax Officers, eligible for promotion to the cadre of State Tax Officer , are included in the Select List for the year 2023. As per Order read as 7<sup>th</sup> above , ASTOs upto Sl.No.11 in the Select List have already been promoted. At present, 29 posts of State Tax Officers are lying vacant in this department consequent to promotion, retirement

and VRS from the department.

As per Order in OA(EKM) No.793/2023 of the Hon'ble KAT dated 02.06.2023, the Hon'ble Tribunal has directed the 2nd respondent, ie Commissioner of State Taxes, to consider and pass appropriate orders on Annexure A4 representation submitted by Sri.Manoj.P, State Tax Officer, Tax Payer Services Circle, Pattambi. The request of the individual has been considered. At present there are no vacancies as pointed out by the applicant and hence he has been posted in next nearest station to Palakkad in this Order. Thus the Order of the Hon'ble Tribunal is complied with.

Sri Rajeeve.K.R (PEN- 153186), who is included as Sl No.15 in the Select List and currently the 4th person to be promoted, is presently working as Deputy Audit Officer, Audit Team, Vaikom in Kottayam District. Since the Model Code of Conduct (MCC) in connection with Puthupally Legislative Assembly (98) bye - election is in force in Kottayam District w.e f 08.08.2023, promoting the individual and consequent transfer at this point of time will result in violation of the MCC. At the same time denying due promotion to the other 28 ASTOs and keeping the posts of State Tax Officers vacant in SGST Dept. are found to be against public interest and state revenue. In the circumstance, Sri.Rajeeve.K.R (PEN- 153186) will be promoted to the cadre of STO after the MCC is over. Separate order shall be issued for protection of his eligible seniority subsequently. Further, in view of the MCC no transfer and posting of STOs are effected in Kottayam District.

After setting apart one vacancy for promoting Sri.Rajeeve.K.R (PEN- 153186) remaining 28 vacancies can now be filled by promoting senior ASTOs included in the Select List for the year 2023, who are selected by DPC (Lower) held on 13.02.2023 and approved by Government.

In the circumstances and in the interest of State Revenue, work and administration the following orders are issued.
