A provisional seniority list of Senior Clerks appointed to the vacancies in the State Goods and Services Tax Department for the period from 01.01.2020 to 31.12.2021 was published and circulated among the Senior Clerks of the department inviting claims and objections. There were 208 vacancies of Senior Clerks during the above period.

The claims and objections received against the provisional list have been duly examined. The objections pointed out by the individuals comprises of corrections with regard to the name of the individual, native district, date of birth, date of eligibility, non inclusion in the list etc. Each representation has been examined in detail with reference to the details furnished by the respective controlling officers.

The following individuals have filed objection stating that they have not been included in the Provisional Seniority list though qualified. The representations have been examined and found genuine. Hence, it is decided to include their names in the list at appropriate place.

Smt.Biji V K contented that she was included as Sn No.175 in the Provisional Seniority list of Senior Clerks appointed to the vacancies for the period from 01.01.2018 to 31.12.2019 and was excluded when the list got finalized and included in the Provisional Seniority list of Senior Clerks appointed to the vacancies for the period from 01.01.2020 to 31.12.2021 as Sn. No 37.

The representation was verified and found that the individual was included in the Provisional Seniority list of Senior Clerks appointed to the vacancies for the period from 01.01.2020 to 31.12.2021 as Sn. No 37, because of the inclusion of some eligible seniors in the final list who were unfortunately omitted from the provisional list.

The contention of Smt.Raji P S is that her junior Smt.Sindhu P Panicker who was included as SI No.27 (UDT) in the Promotion Order CT/9997/2019-A3 dtd. 02.08.2021 got earlier seniority as Sn No 66 above her. On verification of the representation, it is seen that Smt Sindhu P Panicker filed willingness for conversion to the cadre of Senior Clerk on 02.07.2020. Eventhough she was eligible for conversion as senior clerk she was not considered in the previous promotion order CT/9997/2019-A3 dtd 01.02.2021. Hence as per Order No.Ct/6413/2021-G4 dtd 26.11.2021 the Special Commissioner ordered to give her earlier seniority wef the date of willingness ie;02.07.2020. Subsequently she was given seniority wef the promotion order mentioned earlier. Hence the contention raised by Smt.Raji P S has no merit.

Sri. Pranav S has put in a representation for earlier seniority.Representation was examined and found genuine. His Seniority position was revised from Sn No 311 to 307 in the revised Final Seniority list of Clerks for the period from 01.01.2014 to 31.12.2016 dated 17.06.2023. Hence his seniority reassigned as Sn. No. 120.

Smt.Resmi S has put in a representation stating that she is not eligible to be included in this Seniority list and requested for taking necessary steps to exclude her name from the list. On examination it is found out that she is eligible to be included in the list and her contention is devoid of merit.

Smt.Aneesha P M and Manjumol K R contented that some of the officials was included in this seniority list under Rule13B without acquiring AIT&KGST Departmental exams and has enquired whether these officials has acquired test eligibility .

Rule 13 B states that “Notwithstanding anything contained in these rules or in the Special Rules, persons in Government Service who attained the age of 50 years who have put in 25 years of service shall be eligible for permanent exemption from passing the obligatory departmental tests, other than those prescribed as qualification in the Special Rules for all purposes such as promotion, appointment as full member of a service etc”. Hence from the above Rule it is clear that those officials who attained the age of 50 years who have put in 25 years of service are exempted from acquiring departmental test eligibility for promotion to the cadre of Senior tax assistant (Senior Clerk).

They were UD Typists who got conversion as senior clerk contented that their immediate juniors in the cadre of senior clerks as in the Promotion Order got earlier seniority than them and were included in the seniority list of senior clerks appointed to the vacancies for the period from 2020 to 2021 and they were excluded from the list. On verification it is seen that those senior clerks are included in the list based on their feeder category seniority ie; in the cadre of typists. Hence they cannot be considered as the immediate junior in the cadre of senior clerk as they belong to another category. So considering the seniority in the feeder category of typists they can be given sixth seniority position according to seniority.

Their another claim is that they acquired test eligibility prior to the date of their promotion order and they are eligible to get seniority based on it. On verification it is revealed that at that time they belong to the category of typists and are not eligible to be included in the seniority list of senior clerks appointed to the vacancies for the period from 01.01.2020 to 31.12.2021. So their promotion order date to the cadre of senior clerks can be treated as their eligibility date and cannot give seniority according to their test eligibility date. Hence the contentions have no merit and hereby rejected.

Also state that, they are eligible juniors and requested that their names have to be included in this Seniority list as they acquired test eligibility prior to the date of their seniors. On examination it is noticed that they got test eligibility after the date of occurrence of vacancy and their contentions are devoid of merit.

While preparing the seniority list, the date of publication of result of departmental test conducted by the KPSC is one of the eligibility criteria for an individual for promotion to the cadre of Senior Clerk. On verification it is found that all the above individuals have passed the departmental test conducted in 2021 or 2022 .The date of publication of the result of the test by the PSC was on or after 31.12.2021. Hence, the above individuals are not eligible to be included in the Seniority List. They will be included in the upcoming list in the right positions.
