Goods and Services Tax (GST) was introduced in India on 01.07.2017 onwards. Accordingly the Commercial Taxes Department of Kerala has renamed as "State Goods and Services Tax Department, Kerala" and the post of Commercial Tax Officer is re designated as "State Tax Officer" vide orders read 11th and 12th above respectively.

In the above circumstances the candidates advised for posting as Commercial Tax Officers have to be appointed as State Tax Officers on Rs.39500- 1000-42500- 1100-48000- 1200-54000- 1350-59400- 1500- 65400- 1650- 72000- 1800- 81000- 2000- 83000 in the State Goods and Services Tax Department, Kerala, under clause (I) of Sub Rule 9 of General

Rules of Kerala State Subordinate Service Rules 1958 as provided for in rule 10(b) of the said Rules, subject to the conditions laid down in the Special Rules of Kerala Agricultural and Sales Tax Service and Rule 3(c) of General Rules of Kerala State and Subordinate Service Rules 1958. The appointment is provisional subject to final orders in OA EKM No. 1613/17 pending before Hon'ble Kerala Administrative Tribunal.

The above candidates are temporarily posted as Trainee Reserve State Tax Officers in the office of the Assistant Commissioner (Training), State Goods and Services Tax Department, Kerala. As per Special Rules, one year training is mandatory to the newly recruited State Tax Officers. The period of probation in the post will commence only after successful completion of the training. During the training, the trainees will be allowed to draw a consolidated allowance of Rs. 39500/- only per mensem.

The statutory training is scheduled to commence on 01.12.2017. The above Trainee Reserve State Tax Officers are directed to appear before the Assistant Commissioner (Training), Camp office at Gulati Institute of Finance and Taxation, GIFT Campus, Chavadimukku, Sreekariyam, Thiruvananthapuram, Pin 695017 on **01.12.2017 at 10.00 AM** with the following documents along with the memo of advice.

2. Original and copy of Certificate to prove date of birth.
3. Certificate of Medical fitness from a Medical Officer not below the rank of an Assistant Surgeon (thumb impression and attested photo of the candidate should be affixed in the certificate).
4. Original and copy of Non creamy layer Certificate (If required).
5. Original and copy of Community Certificate (If required).
6. Original and copy of Disability Certificate (If required).
7. Two Conduct Certificates issued by two different Gazetted Officers/Panchayat Presidents/ Municipal Chairman/ Mayors.
8. One Time Verification Certificate in original issued by the Kerala public Service Commission.
9. Photo Identity Card such as Aadhar Card/Electoral Identity Card/Driving License/ Passport etc.
