Government ,as per letter read 1st above, have approved the select list of Assistant State Tax Officers for the year 2020 prepared by DPC(lower) meeting held on 14.02.2020 for promotion to the cadre of State Tax Officer. 35 ASTOs have been selected by the Committee.

As per application read 3rd above,Sri. Shankar.K.P, Assistant State Tax Officer, O/o Deputy Commissioner (Produce), Mattanchery, who is the second person in the select list, has submitted that he is relinquishing his right for promotion temporarily for a period of 2 years,citing personal reasons, in accordance with Rule 38 of General Rules of KS&SSR ,Part.II

As per Rule 38 of General Rules Part II KS &SSR "*Any person may, in writing, relinquish any right or privilege to which he may be entitled under these rules or the Special Rules, if, in the opinion of the Appointing Authority, such relinquishment is not opposed to public interest; and nothing contained in these rules or the Special Rules shall be deemed to require the recognition of any right or privilege to the extent to which it has been so relinquished.*"

"The relinquishment of the right for promotion under this rule shall entail loss of seniority and a relinquishment of the right for promotion shall not be permissible unless such relinquishment entails loss of seniority."

Considering the request of the individual permission is granted to Sri.Shankar.K.P, Assistant State Tax Officer for relinquishing his right for promotion to the cadre of State Tax Officer for a period of two years from the date of this order.

At present 29 vacancies of State Tax Officers are existing in this Department. Two vacancies need to be set apart for the following reasons.

- 1.one vacancy to be set apart for giving posting to a trainee STO who will be completing training on 21.08.2020.
- 2.One vacancy to be set apart for an STO who is now under suspension and expected to be re instated into service.

The remaining 27 vacancies in the cadre of State Tax Officers have to be filled up by promoting eligible senior most Assistant State Tax Officers included in the select list for the year 2020.

The following 27 Assistant State Tax Officers are promoted to the cadre of State Tax Officer in the scale of pay of Rs. 39500- 1000- 42500-1100- 48000-1200- 54000- 1350- 59400- 1500-65400-1650-72000-1800-81000-2000-83000 on regular basis under Rule 28b (1) of the General Rules of KS&SSR 1958 .
