NOTE ON GST

Goods and services tax (GST) will be implemented in the country by 2017. All the States are actively involved in GST implementation. The department of Commercial Taxes is the nodal department to follow up all works related to GST. After the successful implementation of VAT in the country, Empowered Committee of Finance Ministers (EC), a society, had continued its mandate to usher in GST. The EC has conducted series of discussions with all stakeholders and conducted meetings of various sub committees regularly for the last 10 years and had evolved the framework of GST. After series of deliberations, the Parliament passed the 101st Constitutional Amendment Act thereby paving the way for the implementation of GST in the country. Soon after Govt of India issued the notification and GST Council, a statutory constitutional body got constituted with Union Finance Minister as its Chairman and all Finance Ministers as members. Now, this body is following up all the matters related to GST laws, rules and its implementation.

At the state level, Hon Finance Minister Dr Thomas Iassac and Shri P Marapandiyam IAS, Addl Chief Secretary (Taxes, Excise, Forest and Registration) have been guiding policy initiatives. Dr K M Abraham IAS, Addl Chief Secretary Finance is guiding GST implementation, especially regarding IT infrastructure, fund settlement and treasury – GSTN – GST information system Kerala network in the State. The department has established the unit for development of software under Shri Mohandhas SIO NIC with the team of experts from NIC and market. For fast-tracking decisions needed for the implementation of GST, an Empowered Committee was constituted in Government involving Taxes, Law, IT and Finance Departments. At the department level, a GST Cell is constituted. The GST Cell is formed to take up all actions with respect to GST roll out in the State. At Department level a steering committee involving all Jt Commissioners, a select number of Assistant Commissioners and Commercial Tax Officers have been constituted. There were sub committees. In the sub committees field officers were included. These sub committees worked on some of the themes such as services, human resource, suggestions in Model law and submitted their reports.

Commissioner along with GST Cell members attend to various committees and groups meetings at state and national level. After each meeting, the chapters of Model law is circulated to all officers and they are asked to give feedback, if any. This way we have ensured involvement of all officers. In the month of June Model GST law was put in public domain. Later on there were series of meetings of GST Law Committee, Rules Committee and GST Council to refine the Law and rules after considering the suggestions received from various stakeholders. During the GST Council meetings after due deliberation of each section, the modifications in the law was approved with some changes. In the 8th GST Council Meeting the first reading of law is over and soon the Model GST law, IGST law and Compensation Law will be cleared by GST Council.

As per the Model GST Law (available version), completed training of 530 (nearly 80% of the sanctioned strength) assessing authorities of the Commercial Taxes Department in coordination with CBEC Govt of India. The Department has established GST Information System development unit under the leadership of NIC. This unit is developing backend

system of GST Information System. Department has already submitted draft SGST Act to department of Taxes in Government for the vetting by the Law Department. The recent changes shall be submitted once the Law is passed by GST Council. The department is preparing for the migration of existing dealers to the GSTN system from 1st JANUARY, 2017 for which necessary points were identified in districts and communication strategy was drawn up.

Once the laws are cleared by GST Council, department is planning series of awareness activities and capacity building program for all the stakeholders including trade and industry and people at large.

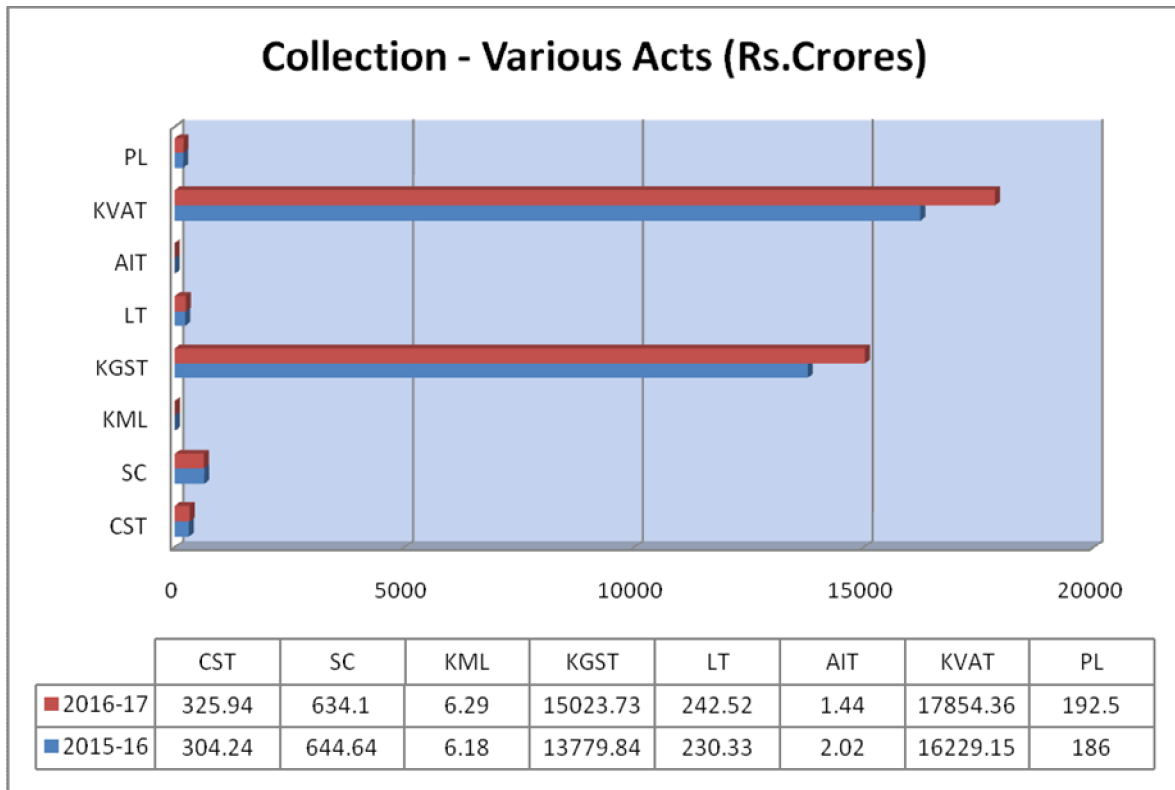

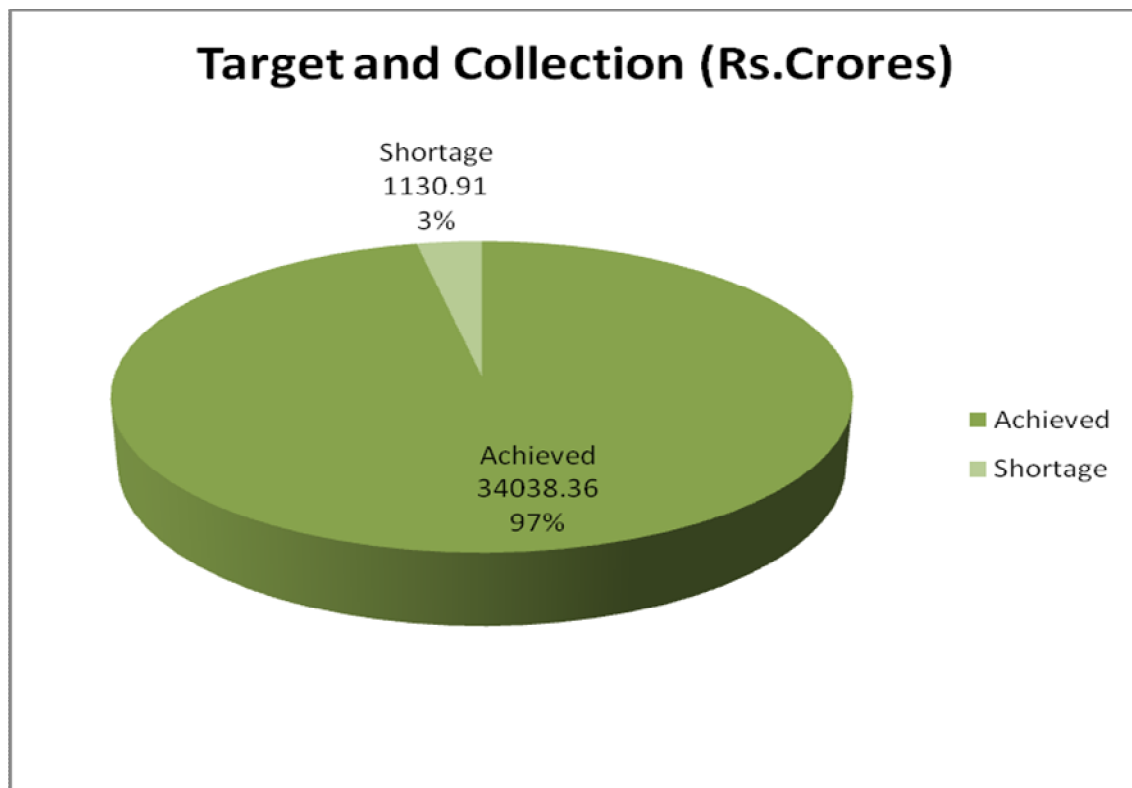

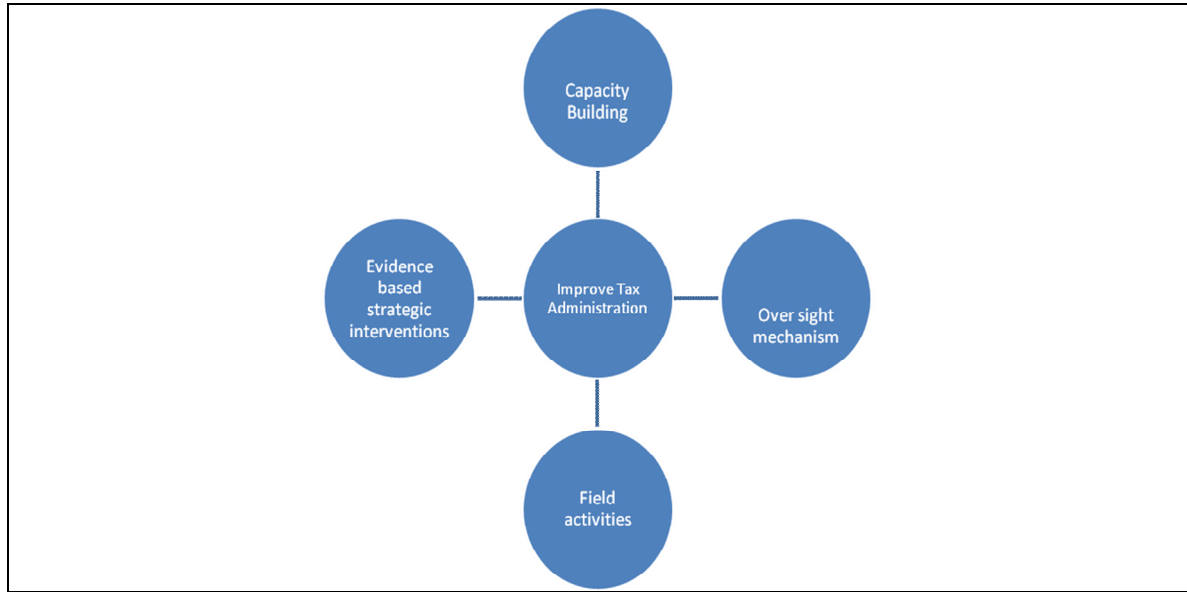

VII THE SYNOPSIS OF STRATEGY AND ACTION PLAN FOR THE YEAR 2016-17

In the Annual Report 2015-16, the first phase the actions taken during the last financial year have been reported. After doing analysis further actions on consolidation of the activities were focused during the current year.

The broad strategy is once again reiterated here.



1. BROAD AREAS FOR INTERVENTIONS

As a long term strategy it was decided that the first year would be year of introduction and settling the new initiatives, the second year is for consolidation of efforts and the third year to take off and to achieve optimal level of performance.

The mission is to make the department the best performing tax department in the country.

Since the last year various initiatives in the areas of capacity building, oversight mechanism, field activities and evidence based strategic interventions were initiated. All these activities got further strengthened in this year. Out of various measures taken and actions under taken the following are few important interventions done at the field level to ensure qualitative and result oriented output.

2. MONTHLY ACTION PLANS OF DISTRICTS.

As stated earlier since last year the department was taking efforts to prioritize the cases which are revenue yielding. In order to ensure it actually happens at the field level, detailed guidelines and circulars were issued indicating the thematic areas to concentrate viz identified cases contributing more than 85% revenue, LAR cases, Int Audit cases, CR and OR cases, Data Mining cases and any other cases identified by the field officers. Within each of these themes the criteria to select was revenue yield from the case. After identifying these cases each Assessing authority was oriented to do proper scrutiny and use of all available data and other inputs to arrive at the correct assessment. Every Dy Commissioner along with officers of the district prepared monthly action plans and accordingly the Dy Commissioners at district level and Commissioner at the state level conducted

reviews regarding the progress by analyzing increase in collection and collectable demand. Some of the districts who properly followed the principles to identify cases and formulated the plans and executed the plans in time bound manner could generate 20% growth at the end of the financial year eg Thiruvananthapuram. This has clearly established that potential cases scrutiny and assessments had given good results in Thiruvananthapuram.

3. HEAD QUARTER MANAGEMENT INFORMATION SYSTEM

At the State Head quarter all the officers always used to see only field activities related information. After series of meetings with Unit officers, it was realized that there are subjects directly handled by the units in the State HQ, however there is no structured mechanism to review and assess the performance. After detailed study, all the respective sections were asked to prepare formats by identifying important performance indicators. Such formats went through changes and got finalized in the meeting of the Unit Officers. Finally a comprehensive MIS was developed. This MIS gives all the information right from the matters referred by Hon FM, Chief Secretary, Secretary Taxes to the each sections' all basic works and important priority works. This way a system is built so that each section knows the universe of their work and what all things they need to complete.

4. OTHER INITIATIVES:

Some of the major initiatives undertaken during the year are as follows –

- The Department established PR Cell and well thought out awareness campaign was launched. The campaign covered all the segments such as people, dealers, tax practitioners.
- Server procurement completed
- Data lab establishment was started to complement the intelligence based works
- Computer lab was established at CTS to impart technical training to officers

5. PUBLICATION:

In order to institutionalize the systems, it was decided to bring out reports on the specific activities and overall performance.

The following reports were published during the year.

- Annual Report
- GST capacity building documents – Model laws
- Field Management information system (Field MIS)
- HQ Management information system (HQ MIS)
- Report on HR
- Report on e Office
- Report on Clarifications
- Report on Circulars

The reports on clarification and Circulars are very useful as these reports gives information of all the clarifications and circulars issued for the last two years. This information is very important to the Assessing authority while doing scrutiny and assessment.

Unlike other departments, the performance indicators of the department are very clear. It sums up to the revenue generation. The input indicators, process indicators, output indicators, out come indicators and impact indicators have been mentioned in the Annual Report. The total collection was Rs 34038.36 crore with 9% growth.

The Department started pre GST formalities in a structured way to cope up with the requirements of the pre GST and post GST period. The VAT dealer migration started from Jan 2017.

The most important achievement during the year was the server procurement. After implementation of VAT the KVATIS was introduced envisaging around 30000 dealers only. The software and hardware sizing was done accordingly. However over a period, the dealer base increased to 2.4 lakh and software requirement got increased many fold. The dealers were facing lot of problems and so the officers. One record download was taking hours. Co-relation of various fields was a very time consuming and difficult task. After series of meetings and quick decisions by Empowered Committee headed by Addl Chief Secretary Finance, the procurement could be done properly. Post procurement management was done effectively by the ITMC, WIPRO, KELTRON and TCS. After deploying the new servers, all the stakeholders Dealers and officers experienced the ease of working on KVATIS.

The department continued its efforts of capacity building, establishing and institutionalizing management practices and consolidated the performance and completely prepared for the smooth roll out of GST.
