THE SYNOPSIS OF STRATEGY AND ACTION PLAN FOR THE YEAR 2015-16

The Department administers Central Sales Tax Act, Kerala surcharge on taxes Act, Kerala Money Lenders Act, Kerala General Sales Tax Act, Kerala tax on luxuries Act, Kerala Agriculture Income Tax Act, Kerala Value Added Tax Act and Kerala Tax on Paper Lotteries Act. It was imperative to do analysis of revenue generation from each of these Acts and identify potential areas to enhance revenue. After identifying the areas, it was necessary to identify which are the actions to be taken at the policy level and the field level. With this approach, series of actions were taken during the year.

It is a known fact that any organization's performance is dependent on the human resource. Therefore extensive discussions were conducted with the senior, mid level offices to understand the capacity building efforts being taken in the department and it was identified as a major gap. Similarly, it was observed that the field officers were not oriented regarding the basic things such A-B-C analysis, Pareto's principles, data analysis etc. Commissioner conducted series of meetings at the State level and district level. Out of all the districts, growth districts were identified and district level meetings were conducted to understand the activities undertaken and over all functioning of district tax administration. After interacting with officers and analysing the overall activities at the field level the following four broad areas have been identified to take series of interventions.



BROAD AREAS FOR INTERVENTIONS

As a long term strategy it was decided that the first year would be year of introduction and settling the new initiatives, the second year is for consolidation of efforts and the third year to take off and to achieve optimal level of performance.

The mission is to make the department the best performing tax department in the country.

1. CAPACITY BUILDING

The capacity building unit strengthened and capacity building plans finalized and executed right from the training to Check post staff to LDC / UDC and Commercial Tax Inspectors to Asst Commissioners. With the specific strategy of induction training to newly recruited officers and refresher training to all others, the Department started giving capacity building inputs.

2. OVERSIGHT MECHANISM

At the State level regular monthly meetings of District Dy Commissioners, Dy Commissioner Intelligence and Dy Commissioners and Asst Commissioner Appeals were conducted. In all these meetings all the issues were discussed in a structured way and detailed minutes were circulated to guide the field functionaries regarding the actions to be taken in each of the areas. This was one way of setting up the priorities and build their capacities with regards to the newer approaches.

These efforts were complemented by introducing a concept of a Nodal officer for the district. These Nodal officers were selected from the State Head Quarters. They were oriented to do field visits, train the field staff at site and also to ensure the implementation of the decisions taken. They were asked to do desk review, identify potential cases and follow up in the field. There were twin objectives viz. to train the Nodal officers to take the mantle of the Dy Commissioner as and when they are posted in the district as well as to ensure the decisions taken at the State level meetings are actually practiced and implemented at the field level to achieve the stated objectives and results.

In order to ensure direct communication and intensity with which the Department was moving for revenue drive especially in the year when one was facing two elections Panchayat and Assembly period, it was ensured that Commissioner conducted two rounds of field visits and meetings in all the Growth Districts of Thiruvananthapuram, Kottayam, Mattancherry (For Taxation purpose Mattancherry is a separate district), Ernakulam, Kozhikode, Thrissur and Palghat. Other nodal officers conducted visits in their respective allotted districts. This made clear to all field staff their roles and responsibilities and priority of the department to improve the revenue collection by identifying suppression and evasion of tax. These meetings were useful to know the field realities because many officers were taking good initiatives at the same time many important cases were seen kept aside could be identified and actions initiated.

The efforts to build capacities of all the staff was not restricted to the structured capacity building inputs and as state above the review meetings at the State and Field level but first time direct meetings with the CTO/ Asst Commissioners' thematic meetings were introduced. A separate meeting of Luxury Tax Assessment Officers, Revenue Recovery Officers – IAC, Works Contract Assessment officers were conducted. These meetings helped all to understand all activities need to be taken up in their respective areas of works. It also ensured uniform activities all across the State.

After covering the field related interventions as stated above, it was felt that the new initiatives were needed at the State head quarters also. Therefore, a system of Unit officers meeting, Section meeting, Specific units such as Economic Intelligence wing, Information Technology management cell meeting, etc was introduced. In all these meetings the subject specific and other generic initiatives were discussed. The objective of these meetings were –

- To develop shared vision of the department
- To take priority policy initiatives to facilitate field activities
- To ensure timely actions by all the respective officers right from Clerks to the Unit Officers headed by the respective Jt Commissioners/

Dy Commissioner Int Audit at the state head quarters.

The major areas are covered in this synopsis and annual report. The series of hundreds of actions under each area, sub area and activities could be studied by going through the minutes of meetings.

3. FIELD ACTIVITIES:

Any strategy is a futile exercise if it is not backed up by specific action plans and execution at the field level. Therefore at the field level on Assessment side the Circle performance analysis was done and on Intelligence side the squad performance analysis was done. Not only these two areas but other areas such as Revenue Recovery, CAG audit, Internal audit and litigation areas were prioritized. In all these areas prioritization principle was introduced. Eg. The assessing authorities were asked to identify high revenue yielding cases and complete their scrutiny and assessment. Similarly the Intelligence officers were oriented to see which were the high revenue yielding Crime Records cases and Offense registered cases to tap. The same principle was adapted for revenue recovery. Regularly the data was collected regarding the stay cases. The cases pending in various appellate forums were prioritized based on the correctness of assessment and revenue yield.

In order to support field activities, Dr K M Abraham Addl Chief Secretary Finance intervened to get all the stay vacated to facilitate revenue growth and conducted every month resource mobilization meeting at his level to impress upon the serious financial situation and to encourage the heads of revenue earning departments to take specific field activities.

All Dy Commissioners field, intelligence and appeals and all field officers were oriented to take priority actions in this way.

4. EVIDENCE BASED STRATEGIC INTERVENTIONS:

At the State head quarters in order to support the field officers lot of activities were undertaken in data analysis and eco intelligence wing. Based on the data analysis specific cases were referred to Dy Commissioners of the districts and Dy Commissioners Intelligence. These cases clearly mentioned pointers and the mismatches to establish suppression and evasion of tax. This was a singular action which has given clarity to the officers regarding how to proceed in scrutiny and assessment. It was expected on the similar lines the Dy Commissioners and Asst Commissioners would find out other cases and complete the assessment works.

Through Economic Intelligence wing efforts were taken to verify C forms, collect data from other sources to improve performance. Eg. Collection of data from LSGI, Town Planning Department, Electrical Inspectorate, Fire Force helped to identify unregistered businesses as well as works contract. Huge tax leakage got uncovered with such strategic actions. The Department has taken efforts to collect the data from Government of India departments and agencies and State Government department and agencies.

From the data analysis the traders/ business doing suppression was identified. This data was used for Intelligence works. In a structured

way the quality of Intelligence works improved. Series of Check post over taking, check post verification were conducted all throughout the state. In a planned way Volvo bus checking , railway parcel checking was conducted. Not only these activities but evidence based cases were investigated. Trade specific cases were identified. Sometime same trade in all the districts were inspected. Other times different trades in select districts were inspected. This was done to improve compliance. In order to continue this strategy throughout the year Addl Chief Secretary and Commissioner explained the matter and continued the operations successfully.

OTHER INITIATIVES:

Some of the major initiatives undertaken during the year are as follows
