

Kerala Flood Cess

Registration procedure in Flood Cess payment Portal

Kerala Flood Cess has been come into effect with effect from 01.08.2019. The tax payers shall collect and pay the Flood Cess amount along with the return for the month of August 2019 to be filed in September 2019. **No option is provided in GSTR 3B return for the payment of Kerala Flood Cess.** Hence, a separate module/link has been developed for the above purpose. The Kerala Flood Cess payment link is provided in the Website of Kerala State GST Department "www.keralataxes.gov.in". For the filing of Kerala Flood Cess return {Form KFC A}, the tax payers have to create user credentials to login to the Kerala Flood Cess Portal provided in the website. For this purpose the taxpayer shall visit the above website {"www.keralataxes.gov.in"} and click on 'Kerala Flood Cess' link provided there. The following window will be displayed.

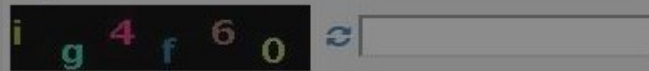


