**S. R. O. No. 518/2018.**—In exercise of the powers conferred by sub-section (1) of Section 9 of the Kerala State Goods and Services Tax Act, 2017 (20 of 2017), the Government of Kerala, on the recommendations of the Council, hereby make the following amendments in the notification issued under G. O. (P) No. 62/2017/TAXES dated 30th June, 2017 and published as S.R.O. No. 360/2017 in the Kerala Gazette Extraordinary No. 1350 dated 30th June, 2017, namely:—

## AMENDMENT

In the said notification,—

(A) in SCHEDULE I—2.5%,—

- (i) after Serial Number 102 and the entries relating thereto, the following serial number and the entries shall be inserted, namely:—
