S. R. O. No. 954/2018.—In exercise of the powers conferred under sub-rule (2) of rule 123 of the Kerala Goods and Services Tax Rules, 2017, the Government of Kerala hereby appoint Sri K. R. Uday Bhaskar, IRS, Commissioner, Central Tax and Central Excise, Thiruvananthapuram who has been nominated by the Chief Commissioner, Central Board of Indirect Taxes and Customs as a member of the State Level Screening Committee constituted as per notification issued under G. O. (P) No. 115/2017/TAXES dated 25th September, 2017 and published as S.R.O. No. 581/2017 in the Kerala Gazette Extraordinary No. 2072 dated

25th September, 2017 in the place of Dr. V. Santhosh Kumar, IRS and consequently make the following amendment to the said notification, namely:—

AMENDMENT

In the said notification, in clause (a), for the entries "Dr. V. Santhosh Kumar, IRS, Central Tax and Central Excise, Thiruvananthapuram", the following entries shall be substituted, namely:—

"Sri K. R. Uday Bhaskar, IRS, Commissioner, Central Tax and Central Excise, Thiruvananthapuram".

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have constituted a State Level Screening Committee on Anti-profiteering with Dr. V. Santhosh Kumar, IRS, Commissioner, Central Tax and Central Excise, Thiruvananthapuram as a member as per notification issued under G. O. (P) No. 115/2017/TAXES dated 25th September, 2017 and published as S.R.O. No. 581/2017 in the Kerala Gazette Extraordinary No. 2072 dated 25th September, 2017. On account of transfer of Dr. V. Santhosh Kumar, IRS to Chennai Central Tax and Central Excise Commissionerate, the Chief Commissioner of Central Tax and Central Excise has nominated Sri K. R. Uday Bhaskar, IRS, Commissioner, Central Tax and Central Excise, Thiruvananthapuram as member of the State Level Screening Committee. Hence, this amendment.

The notification is intended to achieve the above object.
