As per notification issued under G. O. (P) No. 115/2017/TAXES dated 25th September, 2017 and published as S. R. O. No. 581/2017 in the Kerala Gazette Extraordinary No. 2072 dated 25th September, 2017, the Government of Kerala have constituted the State Level Screening Committee as provided under sub-rule (2) of rule 123 of the Kerala Goods and Services Tax Rules, 2017, by which of Sri D.
