Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per sub-section (1) of section 96 of the Kerala State Goods and Services Tax Act, 2017 (20 of 2017) the Government have to constitute, by notification an Authority to be known as the Kerala Authority for Advance Ruling to pronounce advance ruling on application filed under section 97 of the said Act. Accordingly, the Government have decided to notify the said Authority.

The notification is intended to achieve the above object.
