Sub: Implementation of Re-organization of the State GST Department, Kerala – Assigning names to Offices and officials – Guidelines issued -Reg.

Consequent to the implementation of the re-organization of the State GST Department, Kerala, the following guidelines shall be adhered to w.e.f. 10.01.2023, while assigning names to offices and officials. The name and style of names of offices and concerned officials shall be as below:
