Sub: SGSTD – Appointment of designated authority under section 7 of the Kerala Finance Act, 2024 (Act 18 of 2024) - order issued - reg.

Read Kerala Finance Act, 2024 (Act 18 of 2024)

Section 7 of the Kerala Finance Act, 2024 (Act 18 of 2024) empowers the Commissioner of State Tax to appoint one or more officers or a committee of officers referred to in section 3 of the Kerala State Goods and Services Tax Act, 2017 (20 of 2017) to be the designated authority and such authority shall exercise jurisdiction over such area or areas as specified by the Commissioner of State Tax. Hence the following orders are issued.

**Order No. SGST/7442/2023-PLC1-Part(1), Dated 31.07.2024**

In exercise of the powers conferred by section 7 of the Kerala Finance Act, 2024 (Act 18 of 2024) (hereinafter referred to as the said Act), the Commissioner of State Tax hereby appoints a committee of officers chaired by the officers mentioned in column (2) of the Taxpayer Services District mentioned in column (3) to exercise the powers of Designated Authority under the said Act within the Territorial Jurisdiction mentioned in column (4).


