S. R. O. No. 459/2013.—In exercise of the powers conferred by section 10 of the Kerala General Sales Tax Act, 1963 (15 of 1963), the Government of Kerala having considered it necessary in the public interest so to do, hereby make the following further amendment to the notification issued under G. O. (P) No. 47/2005/TD dated 31st March, 2005 and published as S.R.O. No. 319/2005 in the Kerala Gazette Extraordinary No. 683 dated 31st March, 2005, namely:—

33/2625/2013/DTP.

AMENDMENT

In the said notification,—

(a) after sub-clause (iv) of clause (2), the following sub-clause shall be inserted, namely:—

“(v) on the turnover of sale of Aviation Gasoline coming under Serial No. 1, sub-entry (iii) of the Schedule to the Act, to the Rajiv Gandhi Academy for Aviation Technology, a Government of Kerala Undertaking, Thiruvananthapuram, for their use in training aircrafts from the rate specified therein against the description of goods in the Schedule to the Act to five per cent for the period on and from 1st April, 2013 to 31st March, 2016 subject to the condition that the seller shall file the certificate in Annexure V issued by the purchaser.”;

(b) after Annexure IV, the following Annexure shall be inserted, namely:—

“ANNEXURE V

(To be issued by the purchaser in duplicate)

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Government have decided to reduce tax rate payable on the sale of Aviation Gasoline to the Rajiv Gandhi Academy for Aviation Technology, a Government of Kerala undertaking, Thiruvananthapuram, for using in their training aircrafts from 47.62 per cent to 5 per cent for a period on and from 1st April, 2013 to 31st March, 2016.

The notification is intended to achieve the above object.
