## AMENDMENT

In the said notification, in clause (2), in sub-clause (i) in items (b) and (d) for the figures and symbols "23.10%" and "29.92%", the figures and symbols "23.23%" and "30.18%", shall respectively be substituted.

**Explanatory Note**

(This does not form part of the notification, but is intended to indicate its general purport.)

Consequent to the reduction in the price of the Diesel and Petrol on 17th January, 2015 the Government have decided to restore the revenue neutral rate of tax on Diesel and Petrol other than Naphtha under the Kerala General Sales Tax Act, 1963, by amending S.R.O. No. 319/2005 with effect from the 7th February, 2015.

The notification is intended to achieve the above object.
