CIRCULAR.11 / 2010

Sub:- Kerala Tax on Luxuries Act, 1976 – Luxury Tax on Direct to Home (DTH) Service Providers – Operational instructions issued – reg.

- (1) DTH Service Providers are brought within the ambit of Luxury Tax vide the newly inserted sub-section (5) to Sec.4 of the Kerala Tax on Luxuries Act, 1976 as per Kerala Finance Bill, 2010. In order to operationalize this levy, following instructions are issued:
- (2) Every DTH Service Provider in the State shall submit to the Luxury Tax Officer an application for registration in the form annexed as 'Appendix \underline{I} '. Along with the application for registration they shall also submit the following:
 - a) Copy of the Memorandum of Association and Articles of Association and Certificate of Incorporation of the Company,
 - b) Attested copy of the license issued by the Central Government for providing the DTH service .
 - c) Resolution of the Board of Directors regarding the appointment of the authorized person for applying for registration, payment of tax, filing of returns and for receipt and reply of notices and communication from the department and showing the designated business address of the Company in the State.
 - d) A statement showing the details of authorized signatories in Form as in Appendix III
- (3) They shall also furnish security in the form of Bank Guarantee for the amount of tax chargeable for a period of three months.
- (4) The DTH service provider shall file monthly returns in the form 'Appendix-II' in duplicate showing the designated address of the DTH service provider in the State, number of subscribers, the amount received from the subscribers and the amount of tax payable. The proprietor in the first such return for the financial year shall enclose the complete list of names and address of the subscribers and addresses of its dealers / agents / franchisees in hard copy as well as soft copy. The service provider in the subsequent monthly returns shall enclose addition / deletion list of subscribers and dealers / agents / franchisees in the hard copy as well as soft copy. The return along with proof of remittance of tax due shall be furnished to the assessing authority on or before 10th of every month.
- (5) Every DTH service provider operating in the State shall maintain data at his designated office in the State depicting the name of subscribers and their address along with any unique identification number granted by the company to the subscriber, amount received from each subscribers the data should be submitted to the assessing authority or any other officer authorized in this behalf, as and when required and shall be open for inspection.
