

## **GENERAL PROCEDURES FOLLOWED BY THE AWARD COMMITTEE**

### **1. Calling for nominations**

- Nominations were invited from the controlling officers.
- Specific guidelines were given to the controlling officers on the criteria to be adopted of various cadres. It is further suggested that in the communication that A committee of senior officers should be formed under their administrative control for evaluation, awarding the marks and finalization of the nominees.
- The controlling officers were strictly instructed to avoid nominations where disciplinary action cases are pending or punishment has been awarded. The same principle was also adopted in the Commissionerate.
- The period of evaluation was for the financial year 2009-10, except for Check-post mission projects.
- Nominations were called for from the controlling officers twice the number of awards earmarked to each category, except Tribunal. Certain controlling officers have not submitted the requisite number of nominations for want of appropriate candidates as evaluated by the Committee constituted by them.

### **2. Special awards for corruption free checkpost personnel-procedure and criteria**

- The period of consideration in the case of Special Award for Mission, is from the very date of commencing the mission project upto 31-03-2010.
- While doing this exercise, intelligence formation in Mission Palakkad was kept outside the ambit of zone of consideration for Mission Special Awards, as directed.
- Process of selection was completed based on the nominations submitted by Deputy Commissioner, Palakkad. So much so, the very same process was continued in the case of Bengra Manjeswar and Amaravila
- As part of evaluation, Joint Commissioner (Law) visited Office of the Deputy Commissioner, Palakkad to discuss the evaluation process of Mission Palakkad

### **3. Selection**

- As such nominations were received from the respective controlling officers including Secretary, Tribunal.
- Consequent to the receipt of nominations from them, as directed by the CCT, a Committee of Joint Commissioners was formed. Asst. Commissioner I and Asst. Commissioner II were also directed to be incorporated in this Committee to assist the Joint Commissioners.

- Eventually all controlling officers were requested to attend a detailed discussion from 29-12-2010 before the Committee. All of them participated in the meeting and minutes were recorded. Secretary (Tribunal) was not requested to attend discussion, since the list forwarded from the Tribunal was the approved one of Hon'ble Chairman, VAT Tribunal.
- As directed by the CCT, total selection process was done based on the numbers fixed in the Government Order.
- The performance of Law Officers and Addl. Law Officers were evaluated by the Joint Commissioner (Law) based on the evaluation report of Departmental Members of Tribunal.
- There was no nomination from Deputy Commissioner (Appeals), Ernakulam.
- As regards the selection process of Commissionerate, the performance of officials were evaluated by the controlling officers. However, the performance of Assistant Commissioners were directly evaluated by the Joint Commissioners.
- Officials of ITMC has been nominated in full as per the direction of CCT, considering their excellent contribution in the success of e-Governance which also received national recognition and best commends from the Comptroller and Auditor General of India.

#### **Special awards**

- Special awards are granted to five members of Staff for their best contribution in specific work situation. Though the Government Order speaks of Rs.5000/- each to all awardees, the Committee of the view that the award amount may be given based on the cadre to which they belong subject to limiting the amount specified in the Government Order.

#### **Award for daily wage employees**

- The Government Order also envisages award for recognizing due and diligent contribution of daily wages. They are 10 in number.
- Field nominations were taken into account for granting awards under this category.

Based on the above parameters, the Committee decided the awardees.
